

## Appendix VII

#### *Summary*

It also provides, in accordance with Governing Council decision 84/9, information on the net flow of contributions to and payments from the UNDP system in respect of each participating Government. In addition, comprehensive information has been provided on the income and cost of services of management services agreements.
